South Carolina Communities of Care

SCHAC Community Relations Consultants, Danielle Lindley, and Ayana Crawford attended the SCDMH Communities of Care training on Monday, December 5th, 2022.

Hosted by the SC Department of Mental Health's Office of Suicide Prevention, this all-day training was designed to teach participants about the Communities of Care initiative, comprehensive community suicide prevention, and how to apply trauma-informed care in

the workplace and with the communities we serve! The training was designed for community or organizational leaders and focused on how to apply the seven (7) elements of Zero suicide. This framework implements trauma-informed suicide prevention practices to support community members that may be at risk for suicide by accessing the appropriate services and connecting them to resources.

Rural Resource Coalition SC Annual Meeting

On Wednesday, December 7th, SCHAC Consultant, Danielle Lindley, attended the Rural Resource Coalition (RRC) SC Annual meeting at the Brookland Banquet and Conference Center in West Columbia, SC. Leaders from conservation, farming, forestry, tourism, and community economic development come together to discover new ways to work together.

The theme for this year's meeting was "What's on the Rural Kitchen Table: Food, Housing & Energy", and featured three panels: food insecurity and access, rural affordable housing, and energy justice. SCHAC attended the panels on food insecurity and affordable housing to gain resources for our CRCs across the State. Each session provided information on different grant opportunities for these regions and community-based nonprofit organizations that work to partner with interested communities.

SC Food Policy Council Carolina Human Reinvestment, Salt Catcher Farms, and Food Share were the organizations featured on the Food Insecurity panel. The panel focused on regional food challenges that worsened during the COVID-19 pandemic and its ongoing impact. They also discussed different grant opportunities available to help

families, socially disadvantaged farmers, churches, and community-based nonprofit organizations.

SE Housing & Community Development, Habitat for Humanity, and Santee Lynches Affordable Housing and Community Development Corporation were the companies for housing. Panelists spoke about the needs of families in rural SC to secure safe, quality, and affordable housing. They also focused on the current state of affordable housing in SC and the tools practitioners are using to advance affordable housing. The panelists provided several avenues for potential funding for home buyers as well as funding opportunities to end homelessness.

Dr. Martin Luther King Jr., Day of Service

The annual King Holiday Observance is a time to commemorate and honor the life, legacy, and impact of Dr. Martin Luther King, Jr.

The TRUST Network

The TRUST Network was founded in October 2020 to prevent and mitigate violence, stimulated by underlying social issues in the US, in the pursuit of positive peace.

In order to prevent violence, reduce division, strengthen our democracy, and address legacies of injustice, the Network is:

- growing a network of collaboration across sectors in the fields of peacebuilding, social justice, and democracy work;
- establishing a first-of-its-kind citizen-run Early Warning Early Action infrastructure developed specifically for the United States;
- connecting international and national-level expertise and advocacy to local initiatives that are convened by community mediation and justice centers on the ground, so that communities are supported in generating and self-determining

solutions to their long-standing problems (in keeping with the intent of the 1964 Civil Rights Act, Section 10).

Mediators Beyond Borders International (MBBI) is the organizational host. The National Association for Community Mediation (NAFCM) and Center for Peace, Democracy, and Development (CPDD) are key process facilitators. These three founding co-conveners are joined by a rapidly expanding partnership of, currently, 30+ additional organizations and networks, 25 local convening centers and several hundred individuals each of whom has training and/or experience in mediative, restorative or other nonviolent community-building practices.
