***Justice for All* Dialogue Sessions in Columbia!**

On July 21st and 25th, SCHAC Community Relations Division, Robert Snipes, Danielle Lindley, and Ayana Crawford, participated in a series of *Justice for All* dialogue sessions. SCHAC, in partnership with the University of South Carolina's Center for Civil Rights History & Research and the Collaborative on Race, worked to bring diverse cross sections of Richland County citizens together to build trust and create space for discussing issues that face the community today. These dialogues were facilitated by Dr. Jennifer "Bingo" Gunter and Ph.D. candidate at the University of South Carolina, Hector Diaz.

These sessions were centered around the exhibit, *Justice for All: South Carolina and the American Civil Rights Movement*, and connected the legacies of the Civil Rights Movement and the backlash against it to ongoing issues in communities today. The process for these discussions were based on *The Welcome Table*, created by Dr. Jennifer Gunter. These discussions are "designed to help create relational trust, unity, teamwork, and cohesiveness through a group of community members who want to improve racial relations and other problems in their communities. Participants learn better ways to communicate with each other and practice deep listening, which leads to better communication through the telling of our individual stories."

***Meltdown in Dixie* at the Nickelodeon Theater**

On July 13, SCHAC Community Relations Department attended the “Meltdown in Dixie” screening at the Nickelodeon Theater in Columbia, SC. The film explores the broader role of Confederate symbolism in the 21st century and, in the context of race relations, the lingering racial oppression which symbols such as this maintain.

After the screening, there was a panel that featured filmmaker Emily Harrold, former Judge and current Representative Gary Clary, and Representative Justin Bamberg. It was moderated by Dr. Larry Watson. The panel answered questions centered around their experiences in the SC General Assembly when the flag was removed from the State House grounds in 2015. Panelists were also asked a variety of questions, such as if you can legislate morality by using legislation to improve race relations. The audience was also given the opportunity to answer and ask questions.
