**#SPOTLIGHT**: Larry McBride is this quarter's SC Human Affairs Commission **Spotlight** on Success. Larry works as a mediator within the agency in the Legal Division. His commitment to our mission has led to the following results as a mediator from January through March 2022.

### Larry's Q1 Mediation Statistics:

- Total Mediations Conducted: 20
- Percentage Successfully Mediated: 75%
- Total Amount of Monetary Settlements Reached at Mediation: \$396,013

### **Benefits of Voluntary Mediation:**

Mediation allows the parties to resolve the charge in a way that meets their own unique needs. Mediation is a voluntary process, taking place after the charge is filed, but before the investigation begins. While it takes less than 3 months on average to resolve a charge through mediation, it can take 6 months or longer for a charge to be fully investigated. As a result, mediation is a fair and efficient way to assist parties wishing to avoid a lengthy investigation and litigation.

Community Relations Consultants will present at Invest in Peace Conference!



Congress first passed a joint resolution in 1978 authorizing the President to proclaim a week-long celebration of Asian American and Pacific American heritage. President Jimmy Carter's proclamation took place on March 28, 1979, and the first Asian American and Pacific American Heritage week took place the week of May 4, 1979.

Then In 1992, Congress passed legislation recognizing Asian American and Pacific American Heritage Month and its annual designation in May.

The month of May was chosen to commemorate the immigration of the first Japanese to the United States on May 7, 1843, and to mark the anniversary of the completion of the transcontinental railroad on May 10, 1869. The majority of the workers who laid the tracks were Chinese immigrants.
